APPLY ONLY AS DIRECTED. FOR PROFESSIONAL USE ONLY.

Turfgrass: 0.5 to 1.25 fl oz per 1000 sq ft in a water volume of at least 1.5 Gallons/1000 sq ft every 7-14 days during the growing season based on nutritional requirements.

Nursery stock/ornamentals: Apply 2 fl. oz per 1,000 sq. ft. or 2-4 fl. oz. per 1,000 row feet every 5-6 weeks based on nutritional requirements.
